Victim #1 was crossing the street, and the subject turned his wheelchair and stabbed Victim #1 in the right upper chest. Victim #2 observed the stabbing and pepper sprayed the subject. The subject fled in his wheel chair. Victim #3 and EMS were evaluating the subject, who had a steak knife in his right hand. An NOPD officer gave the subject multiple verbal commands to drop the knife, which the subject ignored. The officer deployed his Taser to subdue the subject, and additional officers on scene disarmed and handcuffed the subject. At that time, the subject spit on Victim #3. Victim #1 was transported to an area hospital via EMS. The subject was arrested and relocated to an area hospital for evaluation before booking. PIO notified via Quick Base.
