SAFE-ITR 60-day Sexual Assault Bi-Annual Report – Q3 & Q4 2021

The Sexual Assault Forensic Evidence – Inventory, Tracking, and reporting (SAFE-ITR) program is designed to provide resources toward assisting agencies in addressing the inventory, tracking, and reporting of sexual assault kits (SAKs). The objective is to gain an understanding of the number of SAKs that remain in possession of law enforcement agencies by implementing an electronic and automated SAK tracking system. Understanding the movement of SAKs through the criminal justice system is the goal in the NOPD's implementation of a public transparency website for SAK tracking and reporting.
